

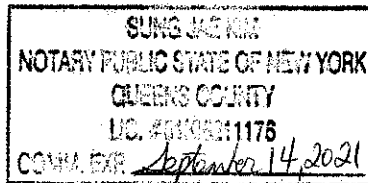

To: **General Unsecured Creditors of Wordsworth Academy, et al.**

Dear Creditors:

We write on behalf of the Official Committee of Unsecured Creditors (the "Committee") of Wordsworth Academy and its affiliated debtors (the "Debtors") in connection with the Joint Chapter 11 Plan of the Debtors, filed on November 8, 2017 (the "Plan"). The Committee is comprised of the following unsecured creditors of the Debtors: (i) Bethanna, (ii) Delta Community Supports, (iii) A Second Chance, Inc., (iv) Child First Services, Inc. and (v) Children's Choice, Inc. The Committee is represented by Cullen and Dykman LLP. The Committee's financial advisors are Walker Nell Partners, Inc.

You should have received the Plan, the Disclosure Statement describing the Plan and certain information material to the Debtor's Chapter 11 case, a ballot for voting on the Plan, and related documents (the "Solicitation Materials") in the mail last week. The Debtors are seeking to have the Bankruptcy Court confirm the Plan so that they can emerge from Chapter 11, subject to the terms of the Plan.

The Committee supports confirmation of the Plan and strongly recommends that holders of unsecured claims (including General Unsecured Claims, Subcontractor Claims and Claims of Staffing Agencies) vote to accept the Plan.

The Plan incorporates a settlement between the Debtors and the Committee. Under the Plan, the allowed claims of all Subcontractors and Staffing Agencies will be paid in full within six (6) months of the Effective Date, which is anticipated to occur on or about January 1, 2018. The Committee also negotiated for non-Subcontractor General Unsecured Creditors to receive their pro rata shares of a \$400,000 fund, double in amount than that originally proposed by the Debtors, which will be paid within that six (6) month period as well. This represents a recovery of approximately 10% by holders of non-Subcontractor General Unsecured Claims, a value 100 times greater than that which holders of General Unsecured Claims would receive if the Debtors were liquidated.

Although M&T Bank has asserted that it is entitled to participate in the distribution fund established for holders of General Unsecured Claims, the Plan does not provide for such participation. In the event that it is ultimately determined that M&T Bank is entitled to participate in the General Unsecured Claim fund, an amended Joint Chapter 11 Plan will be purposed by the Debtors and will be recirculated for voting.

The voting deadline is **December 8, 2017 at 5:00 p.m. (ET)**. Please complete, sign and submit your ballot in accordance with the instructions contained in the Solicitation Package you have recently received so your ballot is actually received by the Debtors' counsel no later than the voting deadline. Please note that only original ballots will be counted and ballots will not be accepted by facsimile or electronic mail.

Although we recommend that you vote to support the Plan, you should review the Plan carefully before deciding how to vote. Please feel free to contact Bonnie Pollack at Cullen and Dykman LLP with any questions.
