**NOTICE OF LOCAL RULE 2016-5 SECOND REQUEST FOR
PAYMENT ON ACCOUNT OF COMPENSATION AND REIMBURSEMENT
OF EXPENSES OF CULLEN AND DYKMAN LLP, COUNSEL TO
THE OFFICIAL COMMITTEE OF UNSECURED CREDITORS,
FOR THE PERIOD SEPTEMBER 1, 2017 THROUGH SEPTEMBER 30, 2017**

TO: The United States Trustee, and all parties that have requested notice pursuant to Federal Rule of Bankruptcy Procedure 2002:

1. Cullen and Dykman LLP (“Cullen and Dykman”), counsel to the Official Committee of Unsecured Creditors (the “Committee”) appointed in the cases of the above-captioned debtors and debtors-in-possession (collectively, the “Debtors”), has filed its *Second Request for Payment on Account of Compensation and Reimbursement of Expenses of Cullen and Dykman LLP, Counsel to the Official Committee of Unsecured Creditors, for the Period September 1, 2017 through September 30, 2017* (the “Request”), a copy of which is attached hereto. The Request seeks approval of interim compensation in the amount of \$35,945.20 (inclusive of a 20% discount) and reimbursement of expenses in the total amount of \$27.37. Cullen and Dykman seeks payment at this time as follows: \$28,756.16 (80% of the fees for services rendered) plus \$27.37 (100% of interim expenses incurred).

2. Any party receiving this Notice may file an answer, objection or other responsive pleading to the Request with the Clerk of the United States Bankruptcy Court for the Eastern District of Pennsylvania, 900 Market Street, Suite 400, Philadelphia, PA 19107-4299, on or before twenty-one (21) days from the date of this Notice. A copy of any answer, objection or other responsive pleading filed with respect to the Request must be served upon Cullen and Dykman at the address set forth below. **Pursuant to Local Rule 2016-5(f), any objection must identify the objector, state the basis of the objection, and identify the amount of the requested payment that is objected to and the amount that is not objected to.**

In the absence of any answer, objection, other responsive pleading, or request for hearing, Cullen and Dykman will certify same to the Court and request that the Debtors pay 80% of the fees requested and 100% of the expenses described in the Request. To the extent objections are filed, Cullen and Dykman will certify same to the Court and request that the Debtors pay 80% of the fees requested and 100% of the expenses described in the Request that are not objected to.
