NOTICE OF FIRST AND FINAL APPLICATION FOR  
COMPENSATION AND REIMBURSEMENT OF EXPENSES OF

TO: The United States Trustee, and all parties that have requested notice pursuant to Federal Rule of Bankruptcy Procedure 2002:

1. Weir & Partners LLP ("**Weir & Partners**"), counsel to the Official Committee of Unsecured Creditors (the "**Committee**") appointed in the cases of the above-captioned debtors and debtors-in-possession (collectively, the "**Debtors**"), has filed its *First and Final Application for Compensation and Reimbursement of Expenses of Weir & Partners LLP, Counsel to the Official Committee of Unsecured Creditors, for the Period July 26, 2017 through January 18, 2018* (the "**Application**"), a copy of which is attached hereto.
