**NOTICE OF (A) POTENTIAL ASSUMPTION AND ASSIGNMENT OF  
EXECUTORY CONTRACTS AND UNEXPIRED LEASES AND (B) CURE AMOUNTS**

**You are receiving this notice because you may be a counterparty to an executory contract or unexpired lease with Buckingham Coal Company, LLC, Oxford Mining Company, LLC, or one or more of their affiliated debtors. Please read this notice carefully as your rights may be affected by the transactions described herein.**

**PLEASE TAKE NOTICE OF THE FOLLOWING:**

1. On October 9, 2018 (the "Petition Date"), Westmoreland Coal Company and certain of its affiliates, as debtors and debtors in possession (collectively, the "WLB Debtors")<sup>2</sup> and the WMLP Debtors, also as debtors and debtors in possession in the above captioned cases, each filed a voluntary petition for relief pursuant to chapter 11 of title 11 of the United States Code (the "Bankruptcy Code") in the United States Bankruptcy Court for the Southern District of Texas (the "Bankruptcy Court").

2. On January 21, 2019, the Debtors filed the *Joint Expedited Motion of the WLB Debtors and the WMLP Debtors for Entry of an Order (I) Approving the Sale of (A) Substantially All of the Assets of Oxford Mining Company, LLC, and Certain of Its Subsidiaries and (B) The Buckingham Mine, (II) Authorizing the Assumption and Assignment of Executory Contracts and Unexpired Leases in Connection Therewith, and (III) Granting Related Relief, Including Approval of the Related Sale Process* [Docket No. [●]] (the “Motion”).<sup>3</sup> Pursuant to the Motion, the Debtors are seeking to sell (a) substantially all of the assets of Debtor Oxford Mining Company LLC and the assets of each of its subsidiaries, other than the assets of Debtor Westmoreland Kemmerer Fee Coal Holdings, LLC (Debtor Oxford Mining Company LLC and each of its subsidiaries other than Debtor Westmoreland Kemmerer Fee Coal Holdings, LLC are referred to herein as the “Oxford Sellers”), including certain executory contracts and unexpired leases (the “Oxford Assets”), and (ii) Debtor Buckingham Coal Company, LLC’s (the “Buckingham Seller” and, together with the Oxford Sellers, the “Sellers”) active thermal coal mine located in Perry County, Ohio and all substantially related assets, including certain executory contracts and unexpired leases (the “Buckingham Mine” and, collectively with the Oxford Assets, the “Assets”). The Motion contemplates that the sale of the Assets will take place via an auction (the “Auction”) governed by the Bidding Procedures attached to the Motion as Exhibit B (the “Bidding Procedures”). Pursuant to the Bidding Procedures, interested potential purchasers must fulfill certain requirements to, among other things, (a) participate in the bidding process, (b) become “Qualified Bidders” and (c) submit “Qualified Bids.” A bid shall not constitute a Qualified Bid unless it is submitted in accordance with the Bid Procedures, and a bidder shall not constitute a Qualified Bidder unless it submits a Qualified Bid. The Debtors, in consultation with the Consolation Parties will determine the winner of the Auction (the “Successful Bidder”) pursuant to the terms of the Bidding Procedures.<sup>4</sup>

3. Pursuant to the Motion, the Debtors may, in accordance with section 365 of the Bankruptcy Code, assume and assign to a Successful Bidder one or more of the Executory Contracts of the Buckingham Seller, listed on the attached Exhibit 1, and of the Oxford Sellers, listed on the attached Exhibit 2;<sup>5</sup> **provided, however**, that the inclusion of an executory contract or unexpired lease on the attached Exhibit 1 or Exhibit 2 does not mean that (a) a Successful Bidder will ultimately identify such agreement as an executory contract or unexpired lease to be assumed and assigned or (b) such contract or lease is an executory contract or unexpired lease within the meaning of section 365 of the Bankruptcy Code. In the event that such agreements are assumed and assigned to a Successful Bidder, the Debtors have identified on the attached Exhibit 1 and

Exhibit 2 the amounts (any such amount, a “Cure Amount”) that the Debtors believe must be paid to cure all prepetition defaults as required by section 365 of the Bankruptcy Code.

4. To the extent not contained in the Motion, all objections to the assumption and assignment of any lease or contract, including, without limitation, any objection to the Debtors’ proposed Cure Amount or the provision of adequate assurance of future performance under any lease or contract pursuant to section 365 of the Bankruptcy Code (“Adequate Assurance”), must (a) comply with the General Objection Procedures (as defined in the *Notice of Auction and Sale Hearing for the Sale of the Debtors’ Assets*, served herewith); (b) identify the lease or contract to which the objecting counterparty is a party; (c) describe with particularity any Cure Amount the claimant contends is required under section 365 of the Bankruptcy Code (a “Cure Objection”) or what the objecting counterparty believes is required to provide Adequate Assurance (an “Adequate Assurance Objection”); (d) be filed with the Bankruptcy Court no later than **February 1, 2019, at 12:00 p.m. (prevailing Central Time)** or **raised at the Sale Hearing** (as defined below) for an Adequate Assurance Objection related only to Adequate Assurance of a purchaser other than the Stalking Horse Bidder; and (e) attach all documents supporting or evidencing the Cure Claim (collectively with the General Objection Procedures, the “Assigned Contract Objection Procedures”).

5. If no objection is timely and properly filed and served in accordance with the Assigned Contract Objection Procedures, (a) the Cure Amount set forth in Exhibit 1 and Exhibit 2 hereto shall be controlling, notwithstanding anything to the contrary in any contract or lease or other document, and the non-debtor party to the contract or lease shall be forever barred from asserting any other claim arising prior to the assignment against the Debtors or the purchaser, and (b) the purchaser’s promise to perform under the contract or lease shall be deemed Adequate Assurance under the contract or lease. To the extent the contract counterparties dispute any Cure Amount provided on Exhibit 1 or Exhibit 2 hereto and cannot resolve such dispute prior to the hearing set for **February 4, 2019, at 9:00 a.m. (prevailing Central Time)** (the “Sale Hearing”), such dispute shall be set for hearing at a subsequent date before the Bankruptcy Court. To the extent the Bankruptcy Court approves the Sale Transactions prior to the resolution of any outstanding Cure Objections, the applicable Executory Contracts will be conditionally assumed and assigned as of the date of the closing, subject to the consent of the Stalking Horse Bidder or other successful bidder, pending a resolution of the objection after notice and a hearing. If a Cure Objection is not satisfactorily resolved, the Stalking Horse Bidder or other successful bidder may determine that such Assigned Contract should be rejected and not assigned, in which case the Stalking Horse Bidder or other successful bidder will not be responsible for any Cure Amount in respect of such contract. All Cure Amounts shall be paid in accordance with the relevant APA.

6. The Court will hear all Adequate Assurance Objections (if any) at the Sale Hearing.

7. Following the designation of a Successful Bid, the Debtors shall file a notice of the Successful Bid, along with copies of the Successful Bidder’s APA and Sale Order, marked to show changes from the form documents previously filed with the Bankruptcy Court (a “Notice of Successful Bid”). A Notice of Successful Bid shall be filed no later than February 2, 2019 and available at [www.donlinrecano.com/westmoreland](http://www.donlinrecano.com/westmoreland). All objections for any specific issues relating

to the Notice of Successful Bid (including, an Adequate Assurance Objection to a Successful Bidder other than the Stalking Horse Bidder) must be asserted **at the Sale Hearing**.

8. An objection to the assumption and assignment of any lease or contract will not constitute an objection to the sale of Asset or the other terms of the Sale Transactions. Parties wishing to object to the Sale Transactions must file and serve a separate objection in accordance with the General Objection Procedures no later than **February 1, 2019, at 12:00 p.m. (prevailing Central Time)**.

9. If you agree with the Cure Amount(s) indicated on Exhibit 1 and Exhibit 2, and otherwise do not object to the Debtors' assignment of your lease or contract, you need not take any further action.

10. **The Debtors' decision to assume and assign executory contracts and unexpired leases is subject to Bankruptcy Court approval and consummation of the Sale Transactions. Accordingly, the Debtors shall be deemed to have assumed and assigned each of the executory contracts and unexpired leases only as of the date of, and effective and conditioned upon, the closing of the Sale Transactions. Absent such closing, the executory contracts and unexpired leases shall neither be deemed assumed nor assigned and shall in all respects be subject to further administration under the Bankruptcy Code.**
