**ORDER APPROVING APPLICATION OF OHIO MACHINERY CO.
FOR ALLOWANCE AND PAYMENT OF ADMINISTRATIVE CLAIM**

Upon the *Application of Ohio Machinery Co. for Allowance and Payment of Administrative Claim* (the “**Application**”)² filed by Ohio Machinery Co. d/b/a Ohio CAT (“**Ohio CAT**”) on January 25, 2019 seeking allowance and payment of an administrative claim in the amount of \$21,738.90 with regard to the debtor, Buckingham Coal Company, LLC (“**Buckingham**”), for parts sold and/or services performed for the benefit thereof from the Petition Date through January 4, 2019; and the Court having jurisdiction over the matter pursuant to 28 U.S.C. § 157; and upon consideration of the Application and the relief requested therein being a core proceeding pursuant to 28 U.S.C. § 157(b); and venue being proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409; and the Court having determined that the legal and factual bases set forth in the Application establish just cause for the relief granted herein; and after due deliberation and sufficient cause appearing therefore:

IT IS HEREBY ORDERED, ADJUDGED AND DECREED THAT:

1. The Application is APPROVED.
2. Ohio CAT is allowed an administrative expense claim in the amount of \$21,738.90

pursuant to section 503(b)(1) of the Bankruptcy Code, with such claim having the priority afforded to

administrative expenses under section 507(a)(2) of the Bankruptcy Code.

3. Buckingham and the WLB Debtors are authorized and directed to pay Ohio CAT its administrative expense claim in the amount of \$21,738.90 within ten (10) days following entry of this Order.

4. The Court shall retain jurisdiction with respect to all matters arising from or related to the implementation of this Order.
