**STIPULATION AND AGREED ORDER RESOLVING DEBTORS’ FIRST OMNIBUS
OBJECTION TO CERTAIN PROOFS OF CLAIM (AMENDED CLAIMS) (CLAIMS OF
ARGONAUT INSURANCE COMPANY)**

The WLB Debtors² and the WMLP Debtors³ (collectively, with the WLB Debtors, the “Debtors”) in the above-captioned cases and Argonaut Insurance Company (“Creditor,” and together with the Debtors, the “Parties”) hereby enter into this stipulation and order (this “Stipulation and Agreed Order”) as follows:

WHEREAS, on October 9, 2018 (the “Petition Date”), the Debtors filed voluntary petitions for relief under chapter 11 of the United States Bankruptcy Code in the United States Bankruptcy Court for the Southern District of Texas (the “Bankruptcy Court”). These chapter 11 cases have been consolidated for procedural purposes only and are being jointly administered pursuant to Bankruptcy Rule 1015(b) [ECF No. 71];

WHEREAS, on October 18, 2018, the United States Trustee for the Southern District of Texas (the “U.S. Trustee”) appointed an official committee of unsecured creditors pursuant to § 1102 of the Bankruptcy Code (the “Committee”) [ECF No. 206];

WHEREAS, the Bankruptcy Court has jurisdiction over this matter pursuant to 28 U.S.C. § 1334, this matter is a core proceeding within the meaning of 28 U.S.C. § 157(b)(2), and venue is proper pursuant to 28 U.S.C. §§ 1408 and 1409;

WHEREAS, on March 2, 2019, the Bankruptcy Court entered the *Order Confirming the Amended Joint Chapter 11 Plan of Westmoreland Coal Company and Certain of Its Debtor Affiliates* (the “Confirmation Order”) [ECF No. 1561] confirming WLB Debtors’ plan of reorganization (the “WLB Plan”);

WHEREAS, on March 15, 2019, the effective date of the WLB Plan occurred (the “Effective Date”) [ECF No. 1608];

WHEREAS, the Debtors filed the *Debtors’ First Omnibus Objection to Certain Proofs of Claim (Amended Claims)* [ECF No. 1784] (the “Objection”) whereby the Debtors sought to disallow and expunge certain claims that were amended and superseded by subsequently filed claims. Specifically, the Debtors objected to the following claims filed by Creditor (collectively, the “Argonaut Amended Claims”):

- (a) Claim No. 2-1 filed in Case No. 18-35693 (DRC Claim No. 545) (“Claim No. 545”);
- (b) Claim No. 33-1 filed in Case No. 18-35696 (DRC Claim No. 550) (“Claim No. 550”);
- (c) Claim No. 4-1 filed in Case No. 18-35697 (DRC Claim No. 553) (“Claim No. 553”);
- (d) Claim No. 3-1 filed in Case No. 18-35698 (DRC Claim No. 555) (“Claim No. 555”); and

- (e) Claim No. 3-1 filed in Case No. 18-35706 (DRC Claim No. 565) (“Claim No. 565”).

WHEREAS, the Objection provides that the following claims filed by Creditor as amendments to the Argonaut Amended Claims constitute the remaining claims (collectively, the “Argonaut Remaining Claims”), which claims are not affected by the relief requested in the Objection:

- (a) Claim No. 2-2 filed in Case No. 18-35693 (DRC Claim No. 546) (“Claim No. 546”) (amending Claim No. 545);
- (b) Claim No. 33-2 filed in Case No. 18-35696 (DRC Claim No. 551) (“Claim No. 551”) (amending Claim No. 550);
- (c) Claim No. 4-2 filed in Case No. 18-35697 (DRC Claim No. 554) (“Claim No. 554”) (amending Claim No. 553);
- (d) Claim No. 3-2 filed in Case No. 18-35698 (DRC Claim No. 815) (“Claim No. 815”) (amending Claim No. 555); and
- (e) Claim No. 3-2 filed in Case No. 18-35706 (DRC Claim No. 566) (“Claim No. 815”) (amending Claim No. 565).

WHEREAS, the Debtors and Creditor have agreed to resolve the Objection, as provided herein.

NOW, THEREFORE, in consideration of the foregoing recitals, which are incorporated into this Stipulation and Agreed Order, the Parties hereby stipulate and agree as follows:

1. The Creditor hereby withdraws the following Argonaut Amended Claims:
 - (a) Claim No. 545;
 - (b) Claim No. 550;
 - (c) Claim No. 553;
 - (d) Claim No. 555; and
 - (e) Claim No. 565.

2. The Debtors hereby acknowledge that each of the following Argonaut Remaining Claims are not affected by the relief requested in the Objection and shall survive entry of any Order regarding the Objection:

- (a) Claim No. 546;
- (b) Claim No. 551;
- (c) Claim No. 554;
- (d) Claim No. 815; and
- (e) Claim No. 566.

3. The Debtors reserve their rights to object to any of the Argonaut Remaining Claims on any grounds whatsoever, and Argonaut reserves all of its rights and defenses in connection with any such objection(s).

4. The Clerk of the Court is authorized and directed to update the claims register maintained in these chapter 11 cases to reflect the relief granted in this Stipulation and Agreed Order.

5. Except as otherwise provided herein, nothing in this Stipulation and Agreed Order, nor any actions taken pursuant hereto, shall be deemed: (a) an admission as to the validity of any prepetition claim against any Debtor entity; (b) a waiver of any Party's right to dispute any prepetition claim on any grounds; (c) a promise or requirement to pay any prepetition claim; (d) an implication or admission that any particular claim is of a type specified or defined herein; (e) a request or authorization to assume any prepetition agreement, contract, or lease pursuant to section 365 of the Bankruptcy Code; or (f) a waiver of the Debtors' rights under the Bankruptcy Code or any other applicable law.

6. Neither this Stipulation and Agreed Order, nor any actions taken pursuant hereto, shall constitute evidence admissible against the Parties in any action or proceeding other than one to enforce the terms of this Stipulation and Agreed Order.

7. The terms and conditions of this Stipulation and Agreed Order shall be immediately effective and enforceable upon entry by the Bankruptcy Court.

8. This Stipulation and Agreed Order is intended by the Parties to be binding upon their successors, agents, assigns, including bankruptcy trustees and estate representatives, and any parent, subsidiary, or affiliated entity of the Parties.

9. The undersigned hereby represent and warrant that they have full authority to execute this Stipulation and Agreed Order on behalf of the respective parties and that the respective parties have full knowledge of, and have consented to, this Stipulation and Agreed Order.

10. The Parties agree that each of them, through their respective counsel, has had a full opportunity to participate in the drafting of this Stipulation and Agreed Order and, accordingly, any claimed ambiguity shall be construed neither for nor against either of the Parties.

11. This Stipulation and Agreed Order constitutes the entire agreement between the Parties with respect to the subject matter hereof and supersedes all prior discussions, agreements, and understandings, both written and oral, among the Parties with respect thereto.

12. This Stipulation and Agreed Order shall not be modified, altered, amended or supplemented except by a writing executed by the Parties or their authorized representatives.

13. The Bankruptcy Court retains jurisdiction with respect to all matters arising from or related to the implementation of this Stipulation and Agreed Order, and the Parties hereby

consent to such jurisdiction to resolve any disputes or controversies arising from or related to this Stipulation and Order.
