**OMNIBUS ORDER AWARDING INTERIM ALLOWANCE OF COMPENSATION  
FOR SERVICES RENDERED AND REIMBURSEMENT OF EXPENSES**  
(Docket Nos. 1334, 1780, 1750, 1734, 1738, 1724, 1726, 1731, 1735, 1739, 1746)

Upon consideration of the fee applications identified on **Schedule 1** attached hereto (the “Fee Applications”) seeking allowance of final compensation and reimbursement of expenses for professional services rendered and expenses incurred in the above-captioned chapter 11 cases during the period from October 9, 2018, through February 28, 2019 (the “Fee Period”); and this Court having jurisdiction over this matter pursuant to 28 U.S.C. § 1334; and this Court having found that venue of this proceeding and the Fee Applications in this district is proper pursuant to 28 U.S.C. §§ 1408 and 1409; and this Court having found that the notice of the Fee Applications and opportunity for a hearing on the Fee Applications were appropriate under the circumstances and no other notice need be provided; and this Court having reviewed the Fee Applications and having heard the statements in support of the relief requested therein at a hearing before this Court on June 5, 2019 (the “Hearing”); and this Court having determined that the legal and factual bases set forth in the Fee Applications and at the Hearing establish just cause for the relief granted herein;

and upon all of the proceedings had before this Court; and after due deliberation and sufficient cause appearing therefor, it is HEREBY ORDERED THAT:

1. Compensation for professional services rendered and reimbursement for expenses incurred during the Fee Period is allowed on an interim basis to the extent set forth for each applicable professional in **Schedule 1** attached hereto.

2. The relief granted herein does not limit any professional's right to seek allowance of the fees and expenses set forth in the Fee Applications on a final basis.

3. The Debtors are authorized and directed to promptly pay all fees and expenses allowed pursuant to this Order.

4. The Court shall retain jurisdiction with respect to all matters relating to the interpretation or implementation of this Order.
