**STATE OF OHIO, OHIO ENVIRONMENTAL PROTECTION AGENCY’S  
WITHDRAWAL OF ADMINISTRATIVE EXPENSE REQUEST [DOC. NO. 1347]**

The June 5, 2019 Order Authorizing and Approving Settlement of Claim Asserted in Adversary Proceeding Number 19-03354 [Case No. 18-35672; Docket No. 1965] resolved the State of Ohio, Ohio Environmental Protection Agency’s (“Ohio”) limited objection to confirmation of the WMLP’s Debtors’ Joint Plan of Liquidation [Case No. 18-35672; Docket No. 1886]. Furthermore, the June 17, 2019 Stipulation and Agreed Order Dismissing Adversary Proceeding [Adv. No. 19-35672; Docket No. 35] dismissed Ohio’s Crossclaim against CCU Coal and Construction, LLC without prejudice. In consideration of the joint agreements in these two Orders, Ohio withdraws the State of Ohio, Environmental Protection Agency's Application for Allowance and Payment of Administrative Expense filed on February 11, 2019 [Case No. 18-35672; Docket No. 1347].
