**ORDER GRANTING FINAL FEE APPLICATIONS OF BAKER & HOSTETLER LLP,  
AS ORDINARY COURSE PROFESSIONAL TO THE DEBTORS FOR (A) FINAL  
ALLOWANCE OF COMPENSATION AND REIMBURSEMENT OF EXPENSES FOR  
THE PERIOD FROM OCTOBER 9, 2018 THROUGH MARCH 2, 2019 WITH RESPECT  
TO THE WLB DEBTORS AND (B) FINAL ALLOWANCE OF COMPENSATION AND  
REIMBURSEMENT OF EXPENSES FR THE PERIOD FROM OCTOBER 9, 2018  
THROUGH JUNE 21, 2019 WITH RESPECT TO THE WMLP DEBTORS  
(Docket Nos. 2150 and 2194)**

Upon consideration of the final fee application of Baker & Hostetler LLP (“Baker”) for final allowance of compensation for services rendered and for reimbursement of expenses incurred as the Debtor’s ordinary course professional for the period from October 9, 2018 to and including March 2, 2019 (the “WLB Final Fee Period”) with respect to the WLB Debtors [Docket No. 2194] (the “WLB Final Fee Application”) and for the period from October 9, 2018 to and including June 21, 2019 (the “WMLP Final Fee Period”) with respect to the WMLP Debtors [Docket No. 2150] (the “WMLP Final Fee Application”); and the Court having reviewed both the WLB Final Fee Application and the WMLP Final Fee Application; and finding that (a) the Court has jurisdiction over this matter pursuant to 28 U.S.C. § 1334, (b) this is a core proceeding pursuant to 28 U.S.C. § 157(b) and (c) venue is proper before this Court pursuant to 28 U.S.C. §

1408; and determining that proper and adequate notice has been given and that no other or further notice is necessary; and after due deliberation thereon; and good and sufficient notice appearing therefor, IT IS HEREBY ORDERED that:

1. The WLB Final Fee Application and the WMLP Final Fee Application are GRANTED as set forth herein.

2. Baker is allowed, on a final basis, with respect to the WLB Debtors, (a) compensation for professional services rendered to the Debtors during the WLB Final Fee Period in the aggregate amount of \$353,796.73 and (b) reimbursement of expenses incurred in connection with such services in the aggregate amount of \$5,808.72, for a total final award of \$359,605.45.

3. Baker is allowed, on a final basis, with respect to the WMLP Debtors, (a) compensation for professional services rendered to the Debtors during the WMLP Final Fee Period in the aggregate amount of \$1,058,748.07, and (b) reimbursement of expenses incurred in connection with such services in the aggregate amount of \$229,886.47, for a total final award of \$1,288,634.54.

4. The WLB Debtors and the WMLP Debtors, as applicable, are authorized to pay Baker the above amounts, less any amounts already paid to Baker on account of fees and expenses incurred by Baker during the WLB Final Fee Period and the WMLP Final Fee Period, as applicable.

5. This Court shall retain jurisdiction with respect to all matters relating to the interpretation or implementation of this Order.

6. This Order shall be effective immediately upon entry.
